When you give to Songs & Smiles, you make a direct and personal impact. You share joy with people living with dementia and with the people providing them with love and care.

We share joy through our singalong shows.

- During shows, we see smiles and laughter and dancing. We see caregivers get out their phones to take pictures and videos, capturing moments to share with family and friends.
- After shows, we hear beautiful words of gratitude. Residents continually tell us how much they love the singalong shows, saying things like: ““You made our day.” ~ “That’s just what we needed.” ~ “Those songs brought back memories.” ~ “I loved every minute.” ~ “I love you!” ~ “God bless you.”
- Don, a resident at a memory care facility in Carrollton, told Eric after a show: “I know all the songs, but I don’t know how to get to them. When you start singing them, then I grab on and I can sing.”
- In the past two years, Eric has presented more than 600 in-person singalong shows, and he has more than 150 shows scheduled between now and the end of the year, including our monthly community singalong shows here in Grapevine.
- Karl, our first volunteer singalong leader, presents 7 shows each month in and around Frisco, Texas.
- Our online singalong videos have been viewed more than 80,000 times.

We share joy through our dementia-friendly magazine.

- We’ve sold copies of *Joyful Memories* magazine to people in 33 different states.
- Almost everyone who has ordered one issue has returned to order our other three issues.
- The AWARE Fund of The Dallas Foundation awarded us a grant to print and distribute thousands of copies in Dallas and Collin counties. We’re partnering with organizations such as the Baylor Memory Center, Jewish Family Services, and The Senior Source to distribute magazines starting next month.
- Our 5th issue, “The Cats Issue” is in the works and will be published soon.

We share joy with caregivers searching for ideas and encouragement.

- We’ve mailed books and DVDs to caregivers in 37 different states free of charge. (Your donations pay for these books and DVDs, plus the envelopes and the postage.)
- We now have more than 1,000 followers on our Facebook page, and our website is visited by thousands of caregivers each month.
